## Introduction

The aim of this module is to introduce students to speech and speechmaking as a political *skill*.

It will look at the practical processes of constructing and then delivering a speech with the aim of convincing an audience of the validity of the arguments being pursued.

This will be measured by the extent to which students demonstrate an understanding of the topics covered in the workshops through their weekly reflective analysis and their practical application to construct and deliver a speech.

As such, this module is aimed at students with a keen interest in developing their communication skills and employability potential, alongside those considering a political career.

## **Delivery**

## **Assessments**

This module will be assessed by a combination of a reflective logbook of concepts covered over the early stages of the module and a live delivered speech. **Submission dates will appear on Canvas under 'Assessments'**.

### ***Assessment One:***

Students will be required to write four **450-word reflective analyses** (40%) drawing on content covered between weeks one and six. This constructs a series of **academically driven** analyses that is to

be submitted via Canvas before the deadline. This will total approx. 1,800 words. Please use citations and include a bibliography. Examples have been uploaded on Canvas.

### **Assessment Two:**

The students will also be required to deliver an original **ten-minute scripted speech** (60%) on a single political controversy/issue which they will have researched over the course of the module. The speech can be on *any* topic of your choosing relating to an issue in *any* country.

Students will be expected to include a bibliography at the end of the transcript highlighting cited relevant evidence-based and academic sources that support your arguments.

The **transcript** of the speech **must** be submitted via Canvas where feedback will be provided.

### **Assessment Notes:**

The copy/pasting of previous submissions of work from other modules (self-plagiarism) is not permitted and risks a penalty mark of 0 (zero).

You may be required to verbally defend your written work in cases of alleged breaches of academic integrity.

Please note that **all** awarded grades are **provisional** until they have been internally moderated and approved by External Examiner, the Module Review Board and the Board of Examiners at the end of the academic year.

### **Disability Support**

Students with support plans will be given alternative options for delivering their speech required by their individual learning needs.

### **Objectives**

The objectives of this module are to equip students with the skills required to develop their speechmaking and presentational skills. It will be a practical application of the rhetorical theories of effective oratorical delivery, applying the performative, judicial, and deliberative forms of communication. It will engage students with the process of oratorical construction, which will assist in the development of their presentational skills and employability potential.

### **Learning Outcomes**

- i) Evaluate the stylistic construction of political speechmaking.
- ii) Classify and apply the oratorical theories and use them to enhance their presentational skills.

iii) Develop a comprehensive mastery of the skills used by political figures to delivery convincing arguments and apply them to their own skillset to enhance student employability.

iv) Deliver a ten-minute political speech.

v) Critically evaluate the importance of political speechmaking, the techniques required, and the impact it can have on delivering a convincing message.
