Eunice Guo has been successful in securing a BA/Leverhulme Small Research Grant in the amount £9,754.40 on her project titled "Food Leftover Management: The Impacts of Sharing Economy and the Pandemics". The project will explore food leftover management based on the trade-off between benefiting the environment and helping the society. The impacts of the pandemics will also be discussed. The project will serve as important references for real practices of food leftover management, and for the policymakers to design appropriate policies.
